Annual summer conference - OASBO conducts multiple professional development opportunities throughout the year. The primary conference is held in the summer and spans 2 1/2 days. Attendance generally averages 250 of our 350 members. We also conduct a one day training in November that is generally attended by more than 180 of our members. We host an annual Winter Conference in conjunction with the superintendent's association which focuses on budget and is attended by approximately 150 people. In the spring we hold regional meetings that span a single day with overall attendance in the neighborhood of 250 individuals. Finally OASBO offers a New Business Manager Institute. The program is specifically designed for new practioners and spans three full years. The institutue typically includes 15-20 members in each annual cohort.

OASBO received a grant from the Oregon School Boards Association for the express purpose of acquiring a suite of data analytic tools for utilization by every district in Oregon.
